RV PARK RULES & WAIVER:

At Brush Country RV Park we value the safety of our customers and want you to have a pleasant visit. Payments are payable in advance – Payments are due on the 1st day of each month.

Failure to pay on time will result in late charges at the rate of \$10.00 per day as well as the possibility of your RV being towed at your own expense and not released until all money owed is paid in full! No refunds for any reason.

Management reserves the right to evict or refuse any person who had evidenced a disregard for the rules without a refund. Guests and their visitors agree to use the campground at their own risk. The management and owners are not responsible for damage, injury or loss to persons, pets or property. We reserve the right to make changes to the rules, regulations and fees that we deem necessary.

1. Speed limit is 5 m.p.h.
2. No loud music or noise that could disturb neighbors.
3. Only 1 RV and two vehicles per site.
4. Pets must be on a leash, under control and quiet at all times. They cannot be allowed to disturb other campers. All pet “poop” must be picked up immediately.
5. Washing vehicles in the park is prohibited, however; keeping your RV clean and in good repair is required.
6. No temporary buildings, structures, outside appliances or gardens, etc. without management approval.
7. No tents, etc. All units must be self contained and meet park standards by being clean and in good repair.
8. Clotheslines or ropes are prohibited.
9. Children driving or riding golf carts or ATV’s must always be accompanied by a parent or guardian.
10. Cleanliness is very important to us; Camp sites must be kept neat and tidy at all times. **NO LITTERING** outside of your spaces as well. Please place all trash, bottles, cans, cigarette butts, food wrappers, etc. in trash receptacles. We strive to keep park clean.
11. No commercial or illegal activity.
12. Parents are responsible for the supervision, conduct and behavior of their children at all times.
13. No loaded firearms or fireworks allowed on premise.
14. Trash bags are to be tied and placed in dumpster.
15. Quiet times are from 10:00 pm to 7:00am.
16. No Campfires.
17. Be sure to close awnings when leaving your rig unattended. Strong winds come about suddenly and cause severe damage.
18. No parking on lawn or roadways.
19. No trimming or wood gathering from trees; you can and will be charged for damages.
20. No heavy mechanical work on premises allowed.
21. Drunk and disorderly behavior **WILL NOT** be tolerated and will result in the contacting of local authorities and expulsion from the park.
22. A sewer hose seal (rubber threaded connector) for your sewer hose is required on all sewer hook ups.
23. Brush Country is not responsible for any electrical components on RV’s.
24. Wireless Internet is for our guests. Brush Country is not responsible for the operations of this service.

All facilities are used at your own risk. The equipment, apparatus and facilities furnished are solely for the convenience of the registered guests only. The management will not be responsible for accidents, injuries or loss of property by fire, theft, wind or acts of god.
